An individual may contribute up to \$2,700 for the primary election and up to \$2,700 for the general election for a total of \$5,400. Couples may contribute up to \$10,800 for the primary/general election from a joint account, but such a contribution requires both signatures. Federal multicandidate PACs may contribute up to \$5,000 for the primary election and up to \$5,000 for the general election. Contributions from corporations, labor unions, federal-government contractors, and foreign nationals (individuals not admitted for permanent lawful residency and/or non-green card holders) are prohibited. Federal law requires McSally for Congress to use its best efforts to obtain, maintain, and report the name, address, occupation, and employer of any individual who contributes more than \$200 in the aggregate in an election cycle.
